2024 Alumni Classic Raise-A-Thon

OFFICIAL RULES

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

- 1. **CONTEST PERIOD**: The 2024 Alumni Classic Raise-A-Thon (the "Contest") begins at 9:00 AM Eastern Time ("ET") on December 22, 2023 and ends at 11:59 p.m. ET on January 29, 2024 ("Contest Period").
- 2. **ELIGIBILITY**: Contest is open to legal U.S. residents of New York, New Jersey and Connecticut, at least eighteen (18) years old at the time of entry, who reside within a 75-mile radius of the arena at Madison Square Garden ("Arena"). Contest is void outside this area and where prohibited by law. Employees, officers, directors, freelancers and independent contractors of MSG Sports, LLC, MSG Entertainment Holdings, LLC (collectively, "MSG"), Northwell Health Foundation (the "Presenter"), New York Rangers, LLC ("Sponsor"), New York Islanders Hockey Club, L.P.
